- **Jobber Program (Level 1 Price):**
 - No minimum purchase is required. This program is offered to qualified businesses which prefer simple selling without stocking. Ideal for online etailers who prefer drop shipping. Simply taking in the orders and we will take care the rest with tracking numbers available to you for your customers. You can also upgrade to Level 2 at any time to meet your business demands.
- **Stocking Program (Level 2 Price):**
 - For first order, minimum purchase is \$500.00 per shipping address.
 - For reorder, minimum purchase is \$200.00 per shipping address.
 - This program is offered to qualified stocking dealers who prefer to stock up inventory. Ideal for businesses which have showroom for item displays, or businesses need stockings to meet their higher sales volume. Drop shipping service also available for Stocking Program. All drop shipping orders will be charged at Level 1 Price.
- **T-Shirts Program :**
 - For first order, minimum purchase is \$700.00 per shipping address.
 - For reorder, minimum purchase is \$300.00 per shipping address.

Terms of Sale

Pricing & Ordering

- All purchase orders must be either faxed or emailed to us. All purchase orders must be signed by an authorized person.
- Orders are usually shipped the same business day they are received. Email notifications will confirm and advise you the status of your order.
- Sales tax is exempted if merchandise is sold for resale only.
- Under Florida state law, we are required to charge 7.0% sales tax on all orders shipped within the state of Florida unless a current Florida Resale Certificate is provided.
- All special orders must be prepaid. No cancellations, refunds, or exchanges on special order items.
- All prices are subject to change without prior notice
- All orders are subject to acceptance by Loft & Company.

Payments

- All drop-ship orders must be paid in full prior to shipment.
- We do not accept company checks for drop ship orders.
- We do not ship COD.
- We accept Visa, MasterCard, and American Express.
- You **MUST** fill out our Credit Card Authorization Form for credit card payments.
- Open account is only available for qualified dealers. Standard term is Net 30 days.
- To apply for Net 30 terms, you must fill out our open account credit application.
- All open account applications are subject to credit approval.
- Any past due account is subject to a late charge equal to 1.5% per month on the unpaid balance.
- Orders will not be shipped to past due accounts.
- A \$25.00 service fee will be charged to any NSF check.

Freight

- All shipments are F.O.B. Tampa, FL. Most shipments are shipped via FedEx Ground or USPS.
- We offer both Ground and Express shipping services.
- For regular orders, actual freight charges will be added to your invoices.
- For all drop ship orders, Ground freight charges to the Lower 48 States are applied as follow.

- Please call for Express shipping quotes for all drop-ship orders.
- We do not drop ship to APO/ FPO addresses. No exemptions!
- We do not drop ship orders outside United States.
- All drop-ship orders are shipped without "Signature Confirmation" unless otherwise specified.
- If you need a signature upon delivery, a \$2.50 surcharge will be added per shipping address.
- Once an item has **shipped**, cancellation will **not** be permitted.

- In all cases, if you refuse your delivery or order is returned for any reasons, you will be charged for the incurred freight charges.
- For drop-ship orders, once the order is shipped to the address you specified and shows "Delivered" from tracking result, we do not responsible for any "non-receivable" situation. No replacement or refund for all "Delivered" orders.
- The responsibility of the seller ceases when goods have been delivered to freight company. All claims for damage must be made to the carrier.

Back Orders

- All items will be shipped according to availability. If an item is not in stock, we will hold a back order for you and ship the item as soon as it becomes available.
- If you do not wish to wait for back ordered items, we will cancel the items you requested upon receiving instructions to do so.
- Loft & Co. will not be responsible for long delays beyond our control.

Returns & Exchange

- Products eligible for return must be new, unused, unwashed, unaltered, and contain all original product packaging and accessories.
- Products must be repackaged properly in the original packaging. Products not in original condition will not be accepted for return.
- RETURN AUTHORIZATION NUMBER must be issued before any returns can be made.
- No returns will be accepted without a Return Authorization Number from Loft & Co.
- Returns for reasons other than damage, defect, or mis-shipment are subject to a 25% restocking fee.
- All shortage claims must be reported to Loft & Co. within 72 hours of customer's receipt of goods.
- All sales are final.

International Orders

- We do accept orders from outside the continental United States. International orders may require additional charges and some restrictions apply.
- No drop-ship orders for international accounts.
- A customer service representative will contact you within 24-72 hours to provide you a final freight quote before your order is shipped.
- Please provide us your account number for Collect Shipment.
- You are responsible for applicable duties, value added taxes (VAT), brokerage fees, or import consumption taxes upon delivery of your merchandise.
- All international orders must be PREPAID.
- We accept VISA, MasterCard, American Express, and bank wire.
